**Cancellation Policies**

If you are registered, but cannot take part for some reason, please notify Iryna Bielefeld by **November 30, 2023** (at the latest). Cancellation is free of charge up to eight days prior to the opening of our conference. From day seven to day five we charge you 50 percent of the conference fee. The cancellation fee rises to 75 percent from day four to day three. On day one and two before the opening of our conference we charge you the entire conference fee in case of cancellation or no-show.

Tutzing is located approximately 35 km southwest of Munich on Lake Starnberg (Starnberger See).



From Munich Central Station (Hauptbahnhof): Take the urban railway S-6 (S-Bahn) or the regional train (RB) to Tutzing. At the train station in Tutzing, take the Bus 958/978 to "Klenzestraße". You will also find cabs at the front entrance of Tutzing train station. From the airport take the urban railway S-1 or S-8 to Munich Central Station and follow the instructions above.



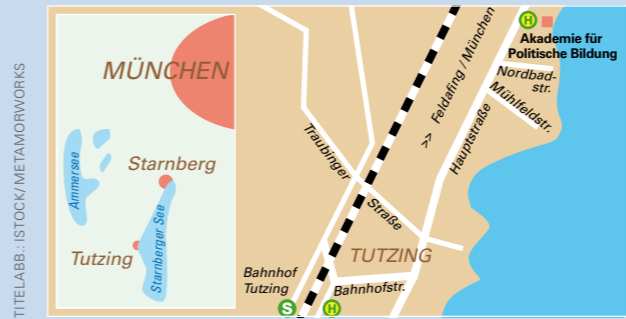
You can also reach the Academy by foot from Tutzing train station. It takes you 20 to 30 minutes.

## INVITATION

The politics of global finance cannot be solely reduced to the power that financial actors exert over states. Instead, a much greater range of actors and structures needs to be considered to pinpoint the sources of political power and influence at work within financial markets, demonstrating the significance of private power and authority within structures of global governance.

Timothy J. Sinclair's work on the politics of credit ratings has been exemplary of such an approach, providing an important legacy for the field of International Political Economy. The demystification of markets as apolitical spaces, the challenge of the notion that markets work according to mechanistic laws of behaviour, and the life-long enquiry into the constitutive social practices of global finance has inspired a whole new generation of scholars.

With this workshop, we want to celebrate Tim's work and learn from early career researchers who explore the politics of global finance broadly conceived and have been inspired in their work by Tim's scholarship. The event also features roundtable discussions on The Politics of Credit Ratings and Future Directions in the Politics of Global Finance.
